



# Gill Dart 15 Inland Championship Gill Grafham Medium Cat Open Sat 26<sup>th</sup> & Sun 27<sup>th</sup> October 2024 NOTICE OF RACE

## **ORGANISING AUTHORITY**

This event will be organised by Grafham Water Sailing Club in conjunction with the Dart 15 Class Association.

The notation '[NP]' in a rule of the notice of race (NoR) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

# 1. RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Grafham Water Sailing Club implements the RYA Racing Charter and competitors will be expected to sail in compliance with it. The Charter can be found at the front of the RYA edition of the Racing Rules of Sailing (the yellow pages after the definitions), or on the RYA website at Racing Charter (rya.org.uk)
- 1.3 If there is conflict between the NoR and SI, then the SI shall prevail. This changes RRS 63.7

## 2 SAILING INSTRUCTIONS

2.1 The event Sailing Instructions will be available at <u>https://webcollect.org.uk/grafham/category/open-events-1</u> by 2000 on Thursday 24<sup>th</sup> October 2024.

## **3** COMMUNICATION

- 3.1 The online official noticeboard is located at <u>https://www.grafham.org/online-noticeboard.html</u>
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## 4 ELIGIBILITY AND ENTRY

- 4.1 For the Medium Cat open the event is open to all cats between 1.175 and 1.400 on the SCHRS.
- 4.2 For the Dart 15 Inland Championship
  - 4.2.1 Boats may enter in any format Una Rig, Two up or Sport Mode.
  - 4.2.2 Boats must sail every race of the Championship in the mode used in the first race. Boats may not change modes during the Championships.
  - 4.2.3 The PY numbers specified by the Class Association are:

UNA rig/2 up---926 Sport mode---- 894

- 4.2.4 Each boat must have at least one competitor that is a member of the UK Dart 15 Class Association. If you need to join the Class Association go to: www.dart15.co.uk/join
- 4.3 Eligible boats may enter by completing the online form at <u>https://webcollect.org.uk/grafham/category/open-events-1</u> together with the required fee by midnight Wednesday 23<sup>rd</sup> October 2024.
- 4.3 To be considered an entry at an event, a boat shall complete all registration requirements and pay all fees.
- 4.4 Any competitors aged under 18 shall complete an Under 18s Consent Form.
- 4.5 Late entries will be accepted at the discretion of the Club, subject to the payment of a late entry surcharge of £10.
- 4.6 The Organising Authority may cancel the event in its absolute discretion, subject to RRS 76.
- 4.7 Should the Organising Authority cancel the event or reject an entry they shall refund the entry fee in full.
- 4.8 On Thursday 24<sup>th</sup> October 2024 a final decision will be made on whether the event can proceed based on the forecast wind strength. In the event of cancellation a notice will appear on the GWSC website by 2000 on that date and full refunds of entry fees will be given.

### 5 FEES

5.1 Entry fees are as follows: for boats sailed by visitors- Singlehanded £59/ Double handed £84 for boats helmed by a GWSC member, who has a registered boat at GWSC-

Singlehanded £20/ Doublehanded £39

5.2 The entry fee includes a 2 course meal which will be served after racing is complete on Saturday 26<sup>th</sup> October 2024. The menu and booking will be within the entry process.

6.1 Does not apply.

## 7 ADVERTISING

7.1 [DP] [NP] Boats may be required to display advertising chosen and supplied by the organising authority.

#### 8 QUALIFYING SERIES AND FINAL SERIES

8.1 Does not apply.

#### 9 SCHEDULE

- 9.1 There is no registration.
- 9.2 Briefing A briefing will be held at 1030 on Saturday 26<sup>th</sup> October 2024 outside the café. If this is not possible, the briefing will be online on the Event Notice board. No event documentation will be issued at the event.

## 9.3 Racing

DateRaceSaturday 26th October 2024Races 1 to 3 sailed back to backSunday 27th October 2024Races 4 to 6 sailed back to back

- 9.4 6 races are scheduled.
- 9.5 The scheduled time of the first warning signal of the first race on Saturday 26<sup>th</sup> October 2024 is 1157.

The scheduled time of the first warning signal of the first race on Sunday 27<sup>th</sup> October 2024 is 1027.

- 9.6 At the discretion of the Class Representatives and the Race Officer races may be brought forward to Saturday to allow for any inclement weather forecasts. This decision will be announced at the briefing.
- 9.7 On the last scheduled day of racing no warning signal will be made after 1500.

### **10 EQUIPMENT INSPECTION**

10.1 Boats may be inspected at any time.

### 11 CLOTHING AND EQUIPMENT

11.1 RRS 40.1 shall apply at all times while afloat.

#### 12 VENUE

12.1 The Sailing Area will be posted on the ONB.

#### 13 COURSES

13.1 The course to be sailed will be a box.

#### 14 PENALTY SYSTEM

14.1 The Post Race Penalty and the RYA Arbitration Procedures of the RYA Rules Disputes Procedures will be available. Decisions from Arbitration can be referred to the protest committee but cannot be reopened or appealed.

#### 15 SCORING

- 15.1 One race is required to be completed to constitute a series.
- 15.2 (a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.

(b) When more than 3 races have been completed, a boat's series score will be the total of her race scores excluding her worst score. This changes RRS A2.

## 16 [DP] [NP] SUPPORT PERSON VESSELS

16.1 Support teams and vessels are not allowed.

## 17 CHARTERED OR LOANED BOATS

17.1 Does not apply.

#### 18 BERTHING

18.1 [DP] Boats and trailers shall be stored so that access for Club members is not impeded.

18.2 [DP] Equipment shall not be placed on Club members' boats.

## 22 RISK STATEMENT

22.1 RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone".

Sailing by its nature is an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions as can be practically provided in the circumstances;
- (g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules or information produced for the venue or event and to attend any safety briefing held for the event.

## 23 INSURANCE

23.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £2,000,000 Pounds Sterling per incident or the equivalent.

# 24 PRIZES

- 24.1 Prizes may be awarded, dependant on entries and at the discretion of the Race Committee, to the square root of the number of entries.
- 24.2 Grafham Water Sailing Club would like to thank GILL for their generous donation of prizes.

# 25 FURTHER INFORMATION

25.1 GENERAL

Campers and camper vans are welcome and pre booking is available online at <u>https://webcollect.org.uk/grafham/category/open-events-1</u>. Pre-booking of camper vans is essential. There is a charge of £15 per night for Campervans, £10 per night for Camping (please note – NO caravans – our lease does not allow them).

Directions to Grafham Water Sailing Club, details of local accommodation, and other information are available on the Club website - <u>http://www.grafham.org</u>.

Entrants and authorised guests are temporary members of Grafham Water Sailing Club during the period of the event and shall comply with Club Rules and Regulations. Failure to observe these may result in exclusion from the club premises.

## 25.3 MOVEMENT OF BOATS TO GRAFHAM WATER

In order to prevent the spread of non-native species there is a requirement to ensure that boats are clean before they visit the site using the principle of Check Clean Dry <a href="http://www.nonnativespecies.org/checkcleandry/index.cfm">http://www.nonnativespecies.org/checkcleandry/index.cfm</a>. This includes:

CHECK your equipment and clothing for live organisms – particularly in areas that are damp or hard to inspect.

CLEAN and wash equipment, footwear and clothing thoroughly. If you do come across any organisms, leave them at the water body where you found them.

DRY all equipment and clothing – some species can live for many days in moist conditions. Make sure you don't transfer water elsewhere.

Anglian Water ask for boats and equipment, arriving at Grafham Water that are from the following locations, to have been clean and dry for at least two days prior to arrival – if not, then they must not be launched at the Club:

- Wraysbury Reservoir and Wraysbury River near to Staines
- The Queen Mother Reservoir
- Queen Elizabeth II/Bessborough Reservoirs
- Queen Mary Reservoir
- Warwick East Reservoir, Warwick West Reservoir and William Girling Reservoir all located in the Lee Valley

#### 25.4 MOVEMENT OF BOATS FROM GRAFHAM WATER

A non-native species of fresh-water shrimp (commonly known as killer shrimps) has been found in Grafham Water and certain restrictions on boat movement have been imposed by AW, DEFRA or other bodies to prevent the spread of these to other locations in the UK. These requirements are prominently displayed on the club premises and will include washing boats and equipment before removal from the Club premises. Failure to comply with the requirements of these restrictions may lead to expulsion from the event.
