BOOKING TERMS

1. RISK STATEMENT

It must be recognised that sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the Event, you agree and acknowledge that:

- i. You are aware of the inherent element of risk involved in the sport and you accept responsibility for exposing yourself to such inherent risk whilst taking part in the Event;
- ii. You will comply at all times with the instructions of Club Officials particularly with regard to instructions for boarding and leaving the boat and/or launching and recovery (as relevant), using the equipment on the boat and handling sails, wearing of buoyancy aids, lifejackets and the wearing of suitable clothing in particular footwear for the conditions;
- iii. You accept responsibility for any injury, damage or loss to the extent caused by your own negligence;
- iv. You will not participate in the Event if your ability to participate is impaired by alcohol, drugs or if you are otherwise unfit to participate;
- v. The provision of supervision by Grafham Water Sailing Club (the "Club") is limited to such assistance, as can be practically provided in the circumstances.
- vi. You understand that the Event is intended to give participants a chance to experience sailing or windsurfing. You will be offered the chance to take part in the activities under the guidance of a representative of the Club who has been assessed by the organiser as competent and sufficiently experienced to supervise your experience. These representatives may not be qualified instructors. The Event is not intended to provide tuition or instruction.

- vii. You are aware of any specific risks drawn to your attention by Club Officials.

2. CANCELLATION

You understand that the Club may cancel or postpone the Event at any stage in the event of bad weather, equipment failure or otherwise.

3. MISCONDUCT

You understand that the Club may exclude anyone from a particular session and evict anyone from the premises who refuses to comply with these Booking Terms or who misconducts themselves in any way or who causes damage or annoyance to other persons.

4. DATA PROTECTION

The Club has a Data Privacy Policy which can be found at www.grafham.org. Your data will be stored and used in accordance with that policy. The information you provide in this form will be used to facilitate your participation in the Event and to contact you. The Club would also like to include your contact details on a mailing list in order to make you aware of membership opportunities and future events

5. PHOTOGRAPHY
